Celebrating Our Accomplishments

We have reason to be proud of our accomplishments in so many areas, and have chosen to highlight a few.

Governance

- **1. Our Mission, Vision and Values:** A committee composed of community stakeholders was involved in the writing of mission, vision, and values statements that will guide the Centre.
- Community Advisory Council (CAC): A second committee, composed of community representatives, has been recruited and charged with advising the VCHC board and management about community needs.
- **3. AGM:** Our first annual general meeting of members was held in November 2007, resulting in the election of an inaugural board of directors, a community advisory council and the appointment of an auditor.
- **4. Accountability Agreement:** Our first Accountability Agreement with the Ministry of Health and Long-Term Care was signed.
- **5. Board Committees:** Committees of the board were formed and their mandates detailed. These committees are: Executive Committee, Board Evaluation Committee, Strategic Planning Steering Committee, Accreditation Committee, and Risk Management Committee.
- 6. Charitable Status: The decision to seek charitable status was approved by the Board of Directors.

Staffing of the Centre

- **1. Project Manager:** In April 2007, Joe Da Silva was hired to support and coordinate the development and initial steps towards the creation of the VCHC.
- **2. First Executive Director:** Isabel Araya was hired on February 25th, 2008 as the first Executive Director of the Centre.
- **3. Staff Recruitment:** Recruitment and hiring for VCHC's staff team started in March 2008. Nina Greco was hired as a full-time permanent Administrative Assistant. Bookkeeping services are currently being provided by Pat Caufin.

Community Capacity

- **1. Capital Project:** The Vaughan Health Care Foundation was approved to proceed with the Capital Project process to build the Vaughan Community Health Centre (VCHC). Stantec Architecture Inc. was selected as the firm to undertake the interior design and development of the VCHC's space. Several meetings were held with community representatives to obtain comment on the design plans.
- **2. Potential Partnerships:** Positive relationships were established with numerous community agencies and local organizations serving Vaughan residents. Many of them expressed strong interest in collaborating with VCHC in service delivery.
- **3. Community Integration:** VCHC participated in various City of Vaughan community events and activities, to facilitate the promotion of future programs and services.

Programs and Services

1. Diabetes Project: A 2008-2009 funding application for the Diabetes Project was written and submitted.

Management

- **1. Policies and Procedures:** The process of creating policies and procedures to guide governance, human resources and administration was initiated.
- **2. Interim Site:** An interim site was opened at 9671 Jane Street, Unit 9, providing us with a visible presence in the community we will be serving.


